**ADDENDUM NUMBER FIVE TO AGREEMENT QZA-19/0212 BETWEEN THE NORWEGIAN AGENCY FOR DEVELOPMENT COOPERATION AND NORWEGIAN CHURCH AID/ KIRKENS NØDHJELP, ADDITIONAL GRANT FOR NEW WATER SUPPLY SYSTEM FOR THE PANZI HOSPITAL IN BUKAVU, SOUTH KIVU PROVINCE, DRC.**

**1 BACKGROUND**

- 1.1 The Norwegian Agency for Development Cooperation (Norad) and the Grant Recipient (jointly referred to as the Parties) have entered into an agreement dated 01.04.2020 (the Agreement) amended by addendum number 1 dated 16.10.2020, addendum number 2 dated 22.10.2020, addendum number 3 dated 20.11.2020 and addendum number 4 dated 09.12.2020 concerning QZA-19/0212 Norwegian Church Aid cooperation agreement 2020-2024 (the Project)
- 1.2 The Grant Recipient has submitted a request to Norad dated 10.02.2021 regarding additional financial support to the Project with which Norad has decided to comply.
- 1.3 The Parties have agreed to amend the Agreement through this **addendum number 5** (the Addendum), which shall be an integrated part of the Agreement.

**2 ADDITIONAL GRANT**

- 2.1 Norad shall, subject to Norwegian parliamentary appropriations and on the terms and conditions of the Agreement, including previous addenda, and this Addendum, provide an additional grant not exceeding **NOK 9,7 million** (Norwegian Kroner four point seven million (the Additional Grant)).
- 2.2 The Additional Grant shall be used exclusively to finance the new water supply system for the Panzi Hospital in Bukavu, South Kivu, DRC
- 2.3 The Additional Grant shall be disbursed upon written request as described in the Agreement.

**3 ADDITIONAL CONDITIONS**

- 3.1 The Support period for the Additional Grant is 01.08.2021 until 30.09.2022.
- 3.2 The Grant Recipient shall submit a separate final report for this addendum by 01.07.2023.
- 3.3 The Grant Recipient shall in the general narrative reporting on the Agreement explain how the Additional Grant contributes to the goals of the Agreement, following the reporting procedures in the Agreement.
- 3.4 The Grant Recipient shall include the Additional Grant in the audited financial report to Norad.

**4 REMAINING CONDITIONS OF THE AGREEMENT**

- 4.1 All other provisions of the Agreement shall remain unchanged and in force.

**5 ENTRY INTO FORCE AND DURATION**

- 5.1 The Addendum shall enter into force on the date of the last signature and remain in force until all obligations arising from it have been fulfilled.
