ADDENDUM NUMBER SEVEN TO AGREEMENT QZA-19/0212 BETWEEN THE NORWEGIAN AGENCY FOR DEVELOPMENT COOPERATION AND THE NORWEGIAN CHURCH AID/KIRKENS NØDHJELP CONCERNING CHAPTER POST 159.76 REGIONAL ALLOCATION FOR ASIA – SUPPORT TO VULNERABLE GROUPS OR THE FREE MEDIA IN MYANMAR FOR THE PERIOD OF 2021

1 BACKGROUND

- 1.1 The Norwegian Agency for Development Cooperation (Norad) and the Norwegian Church Aid (NCA) (jointly referred to as the Parties) have entered into an agreement dated 01.04.2020 (the Agreement) as amended by addendum number 1 dated 16.10.2020, addendum number 2 dated 22.10.2020, addendum number 3 dated 20.11.2020, addendum number 4 dated 09.12.2020, addendum 5 dated 08.07.2021 and addendum 6 dated 17.08.2021 concerning QZA-19/0212 Norad – NCA Cooperation Agreement 2020 -2024 (the Project).
- 1.2 The Grant Recipient has submitted a request to Norad dated 16.08.2021 regarding additional financial support to the Project, with which Norad has decided to comply.
- 1.3 The Parties have agreed to amend the Agreement through this addendum number 7 which shall be an integrated part of the Agreement.

2 ADDITIONAL GRANT

- 2.1 Norad shall, subject to Norwegian parliamentary appropriations and on the terms and conditions of the Agreement, provide an additional grant not exceeding **NOK 3 million** (Norwegian Kroner three million) (the additional grant).
- 2.2 The Additional Grant shall be used exclusively to finance the Project as specified in the budget attached as Annex A to this Addendum and in the Application (ref 1900788-251) during the Support Period.
- 2.3 The Additional Grant shall be disbursed in total upon signing of this Addendum.

3 ADDITIONAL CONDITIONS

- 3.1 The support period for the for the additional grant is 01.10.2021 – 01.04.2022.
- 3.2 The Grant Recipient shall submit a final report by 01.07.2022 in conjunction with the progress reporting on the Agreement. Norad's standard reporting format shall be use.
- 3.3 The Grant Recipient shall in the general narrative reporting explain how the Additional Grant contributes to the goals of the Agreement following the reporting procedures in the Agreement.
- 3.4 The Grant Recipient shall include the Additional Grant in the audited financial report to Norad.

4 REMAINING CONDITIONS OF THE AGREEMENT

- 4.1 All other provisions of the Agreement shall remain unchanged and in force.

5 ENTRY INTO FORCE AND DURATION

5.1 The Addendum No 7 shall enter into force on the date of the last signature, and remain in force until all obligations arising from it have been fulfilled.

This Addendum no 7 has been signed in two -2- original copies in the English language, whereof the Parties keep one each. In the event of any discrepancies between this English language version and any later translations, the English language version shall prevail.
